

## **“Cute Foal” Contest Rules and Regulations**

**3. SUBMISSION PERIOD:** Entries will be accepted from June 14<sup>th</sup> -July 13<sup>th</sup>, 2022 11:59pm CST.

**4. DETERMINATION OF THE WINNERS:** At the end of the submission period (11:59PM Central, July 13<sup>th</sup>), three winners will be randomly selected from all photo entries.
